

ONLINE PRIVACY POLICY AGREEMENT

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Master Moore's Martial Arts Academy , Dojo Disciple LLC of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

If at any point in time Master Moore's Martial Arts Academy , Dojo Disciple LLC decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether to permit the use of their information in this separate manner.

Why We Collect Information and For How Long
